

ORDINANCE 25-09

ORDINANCE LEVYING AND ASSESSING TAXES OF STEGER - SOUTH CHICAGO HEIGHTS PUBLIC LIBRARY DISTRICT, COOK AND WILL COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2025 AND ENDING JUNE 30, 2026.

BE IT ORDAINED by the Board of Trustees of the Steger-South Chicago Heights Public Library District as follows:

SECTION I: That the sum of five hundred and forty-six thousand seven hundred dollars (\$546,700) and no/100 be and the same is hereby assessed and levied from and against all taxable property within the limits of said Steger-South Chicago Heights Public Library District as the same is assessed and equalized for State and County purposes for the current year, 2025. Said taxes are hereby levied the current fiscal year or said Library District commencing July 1, 2025, and ending June 30, 2026, and are to be applied in liquidation of the appropriations of heretofore made by Ordinance adopted by the Board of Trustees of the Steger-South Chicago Heights Public Library District at a meeting thereof regularly convened and held on November 25, 2025 and duly published as provided by law; the various objects and purposes for which said appropriations were made are set forth under the column entitled "Amount Appropriated" and the specific amount hereby levied for each object and purpose is as set forth under the column entitled, "Amount to be Raised by Tax Levy," as follows:

Said appropriation is hereby levied from the proceeds of a special tax for building and maintenance fund purposes in addition to all other Library District taxes.

UNEMPLOYMENT COMPENSATION
